# Minister writes to foster carers

The Minister for Children, Young People and The Promise has written to all foster carers in Scotland as part of Foster Care Fortnight (12-25 May). # Letter from anti-poverty campaigners urge against mothballing

Third Force News has highlighted a joint letter organised by the Poverty Alliance which says people on low incomes will be hit hardest by planned nursery closures in Aberdeenshire. The letter has been signed by around 12 charities and groups ahead of a Council meeting where the closure of four nurseries in Sandhaven, Huntly, Crathes and Aboyne will be discussed.



### Survey findings on childminding delivered from non-domestic premises

The Scottish Childminding Association has shared the findings of a survey of members, which focused on whether legislation and regulations should be changed to permit childminding to also be delivered from non-domestic premises. The survey was launched in response to the shortage of childcare in rural and island areas, the ongoing review of care definitions in Scotland and the introduction of a new category of childminder in England. The main findings show:

- 53 per cent of respondents support childminders having the option to deliver on non-domestic premises (24% per cent opposed, 23 per cent unsure).
- 71 per cent of those in favour prefer a mixed model (home and non-domestic), with only 20 per cent supporting wholly non-domestic delivery.
- Respondents were divided on whether it would be possible to maintain the nurturing, home-based nature of childminding in non-domestic settings: 34 per cent said it wasn't possible, 29 per cent partially, and 28 per cent fully.

### Report highlights gaps and pressures in community child health services

A report by the Royal College of Paediatrics and Child Health highlights the challenges facing community child health services in Scotland. During research for the report, there was found to be a lack of consistent data collection. The report's recommendations outline the urgent need for data, a sustainable child health workforce and positive transitions to adult services.

### Changes to childhood vaccination programme

Public Health Scotland is working with the Scottish Government and NHS boards to make changes to the childhood vaccination programme, following a review by the Joint Committee on Vaccination and Immunisation (JCVI). The changes, which will begin from July 2025, are based on the latest scientific evidence and designed to maintain high levels of protection for children. ### Planned downtime for SSSC website

The Scottish Social Services Council (SSSC) website and MySSSC website will not be available on Monday 26 May until the afternoon of Tuesday 27 May, due to planned downtime. #### Social work bursary uplift

The Scottish Government has announced details of the social work bursary increase for students commencing courses in the academic year beginning August 2025. From 1 June, students will be able to apply for £11,000, split between £6,000 towards living costs and £5,000 for course fees. The scheme, funded by the Scottish Government and administered by the SSSC, will provide support to up to 250 students in the coming academic year.

The Children and Young People's Commissioner for Scotland will host an assembly to celebrate children's human rights on UN International Day of Play, 11 June. Children are invited to attend the interactive session to share views on play that will inform the Commissioner's work on rights to international work.
